Of 70 agencies surveyed in the 50 US States and the District of Columbia, 58 responded to the survey; 17 of those 58 responding agencies indicated that they require institutions to be authorized to operate REGARDLESS OF MEETING A PHYSICAL PRESENCE STANDARD.

The remainder of the categories below list the remaining 41 agencies that USE PHYSICAL PRESENCE AS A TRIGGER for authorization requirements.

The agencies are GROUPED BY TRIGGER; triggers are listed in descending order of the NUMBER OF AGENCIES using that trigger.

2. INSTRUCTIONAL ACTIVITIES – 41 Agencies

All 41 agencies (that responded to the survey AND use physical presence as a trigger), listed below, require AIITP to be authorized by that agency if the institution CONDUCTS INSTRUCTIONAL ACTIVITIES IN THE STATE WHERE STUDENTS MEET FACE TO FACE.

• About 3/4 of these agencies also require authorization for AIITP who are ALLOWING STUDENTS TO CONDUCT INTERNSHIPS OR EXTERNSHIPS IN THE STATE.
